Through negotiation, the parties hereby agree to sign the Memorandum of Understanding (MOU) with the contents and conditions as below:

ARTICLE 1 – CONTENTS

- The Vietnam Record Association was established under the Decision of Ministry of Home Affairs of the Socialist Republic of Vietnam. Vietnam Record Association is the representative in the cooperation between Vietnam and World Records University. *(the Decision of Establishing Vietnam Record Association is attached to this MOU)*
- The Vietnam Record Association is the unit that allowed to nominate and sent documents related to Practical Bachelor and Honorary Doctorate to World Records University (WRU).
- The Vietnam Record Association is a comprehensive strategic partner of World Records University (WRU) with the aims of supplying lectures who are Vietnamese record holders and content values of Vietnam to educate globally.

- World Records University (WRU) must complete the legal procedures in India to deploy this cooperation. WRU is responsible for bringing trainers to Vietnam to train record holders globally, providing lectures and materials for online training on the internet.
- Furthermore, the Vietnam Record Association delegated to the Vietnam Records Organization (VietKings) the task of nominating documents from record holders who have spent their entire lives producing results from real-life practice and contributing those results to community and society.
- The Vietnam Record Association proposes that the World Record University (WRU) confer Honorary Professor Certificates on record holders who have the ability to educate, train, and share their knowledge and experience with young students and record holders.
- The Vietnam Record Association delegated to the Vietnam Records Organization (VietKings) and Vietnam Records Institute (VietMaster) the task of deploying this cooperation.

ARTICLE 2 : PROCEDURE

- 2.1. Both parties based on the spirit of volunteerism, goodwill, cooperation and mutual benefit to carry out the purposes of Article 1 in this MOU.
- 2.2. The Parties agree on each specific job in the Contracts signed by both parties.
- 2.3. The parties consider documents related to the content of work, implement works on time as agreement between the parties.


ARTICLE 3 : CONDITION
